# **Public Policy**

#### Roe v. Wade 46th Anniversary

# The 46th Anniversary of the Roe v. Wade Supreme Court decision will be celebrated at the New Mexico Capitol Rotunda on January 18, 2019, 10-11 a.m.

The New Mexico Coalition for Choice will be hosting the event and discussing a plan to address the growing threat to women's right to choose and privacy rights if Roe v. Wade decision is overturned at the federal level. The Respect NM women campaign is working to make the public aware that New Mexico has archaic language in its statutes that criminalizes abortions. Numerous legislators have expressed their commitment to pass legislation to remove this discriminatory law and several are scheduled to speak at the event in support of reproductive justice.

The 1960's New Mexico statute made it a felony for an abortion provider to terminate a pregnancy, with exceptions for rape, birth defects and serious threats to a woman's health. The law has been unenforceable for 45 years because of the Supreme Court's ruling. New Mexico is one of nine states that retain abortion bans that are not enforced because of the Supreme Court decision. Four more states have laws that would automatically ban abortion if the Supreme Court rescinds the Roe v. Wade decision that legalized abortion.

# Title IX Under Attack

On November 16, 2018, the Department of Education issued a plan to significantly weaken Title IX's protections by narrowing the definition of sexual harassment, limiting when schools will report, and thus make it harder to report sexual harassment and abuse. Until January 15, we have the opportunity to weigh in with the U. S. Department of Education on proposed changes. It is critical that advocates speak up and fight back against attacks on Title IX that will diminish students civil rights. To learn more and make your voice heard go to **aauw.org/take action**.

# **Constitutional Amendment 2 Passes**

AAUW-NM supported the passage of Constitutional Amendment 2 which was approved by a 75.1% vote on November 6, 2018. The amendment added a new section to Article 5 of the Constitution that provides for the establishment of an Independent Ethics Commission. The next step will be to pass enabling legislation. AAUW Lobby Corps member, Nina Thayer of the Los Alamos AAUW Branch will monitor the bills for implementation of the commission during 2019 legislative session. She will provide information to AAUW-NM members when there is a need to advocate for enabling legislation.

#### 2019–21 AAUW Public Policy Priorities

Every two years, AAUW members vote on revisions to our <u>Public Policy Priorities</u>. The Public Policy Priorities establishes our organization's federal action priorities, as well as guidelines for state and local action. The AAUW Public Policy Committee (APPC) has recommended changes to the Public Policy Priorities. Through January 11, 2019, you can comment in support of these updates or suggest changes to the Public Policy Priorities that you'd like to see on the ballot in the AAUW national election in the spring.

Changes that align the Public Policy Priorities with the Strategic Plan appear highlighted in YELLOW

Changes that streamline the Public Policy Priorities or are editorial fixes appear highlighted in **BLUE**.

Changes that are responsive to member leader or APPC input and clarify or detail our support for specific issues appear highlighted in GREEN.

Here's how to comment:

- 1. Read the current AAUW Public Policy Priorities and review the proposed changes.
- 2. Scroll through the comments that have already been posted, if any.

3. Follow the prompt, type your comment in the box, and click 'Post Comment' You can add your thoughts to other comments by clicking 'Reply' to their submission or clicking on the thumbs up or thumbs down to indicate your preference on the comment. You can also choose to receive an email when someone comments on a particular comment by using the 'Manage subscription' function.
