Election of Officers

The AAUW ABQ Board met via Zoom on May 18. Due to the limitations caused by the pandemic, the board members discussed how to handle the election of officers which should have occurred in April at the general

Nominating Committee Report

Election of Officers

The Bylaws of AAUW-Albuquerque say that nominees should be voted on in person. In this time of the pandemic with no meetings, I, as the Nominating Committee Chair, have a proposal to make, similar to the one which AAUW-NM followed.

"I move that we present the nominees to the membership by e-mail. (Pat Maben could help with this via Constant Contact and e-mail.) The e-mail would say, 'The nominee for President is Patricia Maben, and Co-Chair Membership nominees are Danielle Martin and Monique Dodd. If you are opposed to these nominees, send back a "nay" vote no later than one week from this date. If you favor these nominees, do nothing.' If these nominees are approved, they will be sent to National and included in our yearbook. This is contingent on these nominees being voted on at the next general meeting."

The motion was seconded and passed.

Below is the process we will follow to implement the above action of the board.

- 1. Pat Maben will send an e-mail to each member of the Albuquerque branch with a list of the proposed officers as submitted by the Nominating Committee. Please watch for this e-mail which will be sent on May 26.
- 2. If you are in favor of the slate of officers, you do not have to do anything.
- 3. If you are opposed to one or more of the officers please indicate by sending an e-mail to Shila Marek at shila.marek@gmail.com indicating your opposition to one or more of the candidates.
- 4. Members on the mailing list will be mailed the newsletter. If a member is opposed to one or more of nominated officers, they are to call Shila Marek at 369 1521 and inform her of their opposition.
- 5. The Calling Committee is being asked to call the members on their page to notify them of this process.
- 6. At the first general meeting this fall, the members present will be asked to confirm the election of the nominees.

Monique Dodd

Monique Dodd has been working as a Pharmacist Clinician at TriCore Reference Laboratories since July 2016. She is currently Manager of Enterprise Clinical Solutions for the Diagnostic Optimization team. Her role is to design laboratory-driven targeted interventions to optimize screening, diagnosis, monitoring and treatment of high cost, high risk and high frequency health conditions. Her areas of focus are infectious diseases, chronic pain management/opioid abuse and anticoagulation. Dr. Dodd has a unique education background which brings laboratory diagnostics and pharmacy together. She earned her Bachelor's of Science in Medical Laboratory Sciences from the University of New Mexico Health Sciences Center in 2007. She was hired at TriCore as a Medical Technologist working for the Infectious Disease Research and Development team where she worked for three years. She was then accepted to the University of New Mexico College of Pharmacy in 2010 where she interned in the infectious disease lab. Upon graduation in 2014, she entered into a collaborative Post-Graduate Year-One Residency with TriCore and the University of New Mexico College of Pharmacy, with a focus in clinical pharmacy and laboratory diagnostics. Through this existing partnership, she continued her training and earned her Pharmacist Clinician license while completing a Pharmacy Fellowship in 2016. As a member of the Diagnostic Optimization team, Dr. Dodd focusses on designing actionable and real-time targeted intervention for payers, health systems and providers that aim to improve the health of the population.

When asked why she decided to join AAUW, she said it was due to Joy Donelson. Monique received an award from Joy. She related that she so impressed with Joy's passion for promoting women in leadership roles. Joy talked to her about the mission of AAUW and she decided to join.

Planning for 2020-2021

Planning for the upcoming program year is difficult during a pandemic. Ted Cooley and Joan Goodman, co-vice presidents for programs are working on the schedule for the upcoming program year. In September the board is hopeful that the limitations on the size of groups will have changed so that we can accept Janet Matwioff's invitation to have our September meeting in her garden. AAUW ABQ Stem Task Force

The Central New Mexico Science & Engineering Research Challenge was changed to awards for only high school students. Some middle school students were able to present their projects, but no awards were given. The task force decided to give the award money (collected from our members) to two of the high school after their presentations were viewed online.

Recipients were as follows:

- 1. First Place and Grand Ward Winner Ana Maris Perez of Albuquerque Academy. Her project title was On a Variation of the Witsenhausen Problem Concerning Maximal pi/2 Avoiding Spherical Sets
- 2. First place and ISEF Finalist Paulina Naydenkov of Albuquerque Math & Science. Her project title was Hierarchically Engineered Nanotheranostic for Ovarian Cancer

Tech Trek was advised by AAUW National to cancel or convert to online programming due to the pandemic. Instead of either, the Tech Trek committee decided to postpone Tech Trek NM 2020 to 2021. Next year there will be two separate one week camps in the summer. Girls selected for the 2020 camp will be accepted for one of the 2021 camps.

The Tech Trek Committee is creating a Tech-Trek-in-a-box for the trekkers to use doing the week of the 2020 camp. Claudia Poglitsch, Dana Roberson, Cheri and Burch from our branch along with Cheryl Leung (a long time Tech Trek teacher) and Kim Linder (Honeywell Engineer and alumna mom are working on this project. Honeywell and Facebook have supported this project financially.

Tech Trek alumnae have been notified of New Mexico Out of School Time Advancing in STEM scholarships. The STEM Task Force has communicated with MOST about serving on their committee for planning for their focus on girls this year.
