## **President's Message**

Two important announcements have been issues by Board of Directors of AAUW recently. In December members were notified that there will be an increase in 2021 dues and a change in the bylaws related to qualifications to be a member of AAUW A notice about a dues increase was sent out in December by the board president to all members. As with most organizations during this difficult time, AAUW Board of



Director's voted to raise the cost of membership by \$3 to \$62 effective in FY 2022, \$5 for FY 2023, and \$5 for FY 2024. All but \$3 of the annual dues are tax deductible.

Below is a copy of the notice sent to members earlier this month,

This spring each member of the Albuquerque Branch will have the opportunity to vote for a change in the requirements for membership which created a barrier for women who do not have a college degree. By eliminating this requirement, AAUW would become a more diverse and inclusive organization better aligned with the needs of women today.

The membership will vote on a change in the bylaws this spring. Below is information about the bylaw revision. The board believes that this change is a critical step in bringing AAUW's bylaws and membership requirement in line with the mission of advancing equity for women and girls. The board statement states that "AAUW is fiercely committed to educational attainment for all women given our commitment to inclusion, this is simply the right thing to do."

Proposals to eliminate the degree requirement for membership have come before the membership for vote a number of times. The Board feels very strongly that, while the degree requirement made perfect sense at AAUW's inception, this requirement is now counter to our mission and limits our ability to build the capacity needed to increase our impact as an organization. Now through February 5, 2021, you can comment on the proposed changes. All submitted comments or proposed changes will be reviewed by AAUW's staff and the AAUW Governance Committee. Debate on open membership will take place in national town halls and state and branch meetings this spring.

Members can comment on the proposed amendment from January 11 through February 5, 2021, 5:00 p.m. ET. Voting will open on April 7 and close May 17, 2021, 5:00 p.m. ET.

#### Martinez v. State of New Mexico

Diane Torres-Velasquez, PhD, associate professor in the College of Education and Human services at the University of New Mexico was the speaker for the branch meeting on January 9, 2021. Dr. Torres-Velasquez is a noted researcher in the area of multicultural education. She has been involved with the lawsuit Martinez v. State of New Mexico since its inception.

The first information she gave us was that the *Martinez v. State of New Mexico* lawsuit (2014) and a separate lawsuit, *Wilhelmina Yazzie v. State of New Mexico* (2014) are two separate lawsuits. The Martinez lawsuit was filed on behalf of fifty-one Latina, Latino and Native American parents on behalf of their children by the Mexican American Defense and Educational Fund (MALDEF) against the New Mexico Public Education Department (NMPED). The Yazzie lawsuit was filed by the New Mexico Center on Law and Poverty on behalf of school districts and New Mexican Families. The state district court that was hearing the two cases, consolidated the cases for trial. In 2018, the court found the case in favor of the plaintiffs and threatened to enjoin the state's school finance systems if the state did not correct the deficiencies.

The Mexican American Legal Defense and Educational Fund held a series of meetings across the state from Las Cruces, to Albuquerque, Suni, Magdalena, Albuquerque, Santa Fe and Española. People came forward and talked about their dissatisfaction with the education their children were receiving. They also expressed frustration with the challenges related to the current Department of Education. The lawsuit argued that the financial support for education of low-income students, English learners and students with disabilities was not adequate and therefore violated the children's right to a fundamental and sufficient education.

One of the most disturbing issues she raised was that there have been and may still be a prevailing perception among educators and legislators that Mexican American and native American students and their families do not value education. Through studies conducted by educational researchers demonstrated that this perception is erroneous. She shared several stories about children whose lives were changed dramatically after participating in multicultural classes.

Another major problem is that school textbooks do not include multicultural information. It is very important that indigenous, black, Mexican American and Asian children are exposed to their own history and that their cultures are honored. Dr. Torrez- Velasquez and other researchers have found that when



children of color participate in multicultural educational experiences, their academic performance dramatically improves.
