AAUW-ALBUQUERQUE SCHOLARSHIP

The original recipient withdrew her acceptance for personal reasons. The Scholarship was then awarded to our other nominee Maya Shamsid-Dean and she has accepted. Maya is a returning New Mexican. She received her BS-Biology from the University of Alabama, her MS-Biology from Northern Arizona University and is beginning PhD studies in the Biology Department at UNM. Maya was active in promoting STEM to minority women undergraduates and promoting both racial and gender diversity at NAU. The Scholarship Committee this last year was: Pat Maben, Jaclyn Page, Janet Matwiyoff and Sylvia Fink. We had an exceptionally difficult decision between the original awardee and Maya, so we are pleased that Maya was able to accept.

BRANCH PROJECT GRANTS

If you have any ideas for a project you would like the branch to consider implementing this year, please let a Council member know. Below are the rules for asking for money to support projects from the State organization.

Branch Project Grants of up to \$200 per branch per year, are awarded in October. \$600 is in the budget to support branch project grants for 2022-23. If all monies are not allocated in the fall, second applications may be accepted in the Spring.

A branch seeking a Branch Project Grant shall submit to the chair [Sylvia Fink, sisfink@gmail.com] or 5108 Marcadas Rd NW, Albuquerque, NM 87114-4367] a proposal in writing, preferably via e-mail, in a format of the branch's choosing. The project must have an outreach, education, or mentoring component. The application needs to be submitted no later than October 1. Applications must include the Branch name, contact person, e-mail, and mailing information:

- Project Summary.
- Grant Amount being requested.
- · Simplified budges of project costs; and
- A list of contributors/supporters, if any.

The Chair forwards copies to the task force members [assembled from non-applicant Branches] for review and comment. After the Task Force has considered the applications, it may recommend a grant of less than the full amount requested. Grants will be announced at the Fall Leadership Team Meeting.





PUBLIC POLICY NEWS

The Paid Family and Medical Leave Coalition has been very active advocating for the Act and supported the allocation of \$160,000 for Workforce Solutions to study the implementation of the Act. The Coalition has reorganized over the summer. We now have subcommittees for: Communication, Government Engagement, Field [community engagement], and Business Outreach.

Our AAUW-New Mexico commitment: Our AAUW-NM Public Policy Committee will share information with Advocacy Team and members interested in this issue. They will be asked to do an action such as: letter to the editor, send in an Op-ed, ask local government for supporting resolutions, visit with a candidate, legislator, or small business owner, testify at a hearing.
